C: How Your Information is Used:

The information collected about you is for the following purposes:

If we want to use your information for any other purpose, we will ask you for consent and will use your information only on receiving your consent and then, only for the purpose(s) for which grant consent unless we are required to do otherwise by law

D. How Your Information is Shared:

Personal Information is not sold or rented to any third parties.

Information may be shared with Data Processors (service providers) who perform functions on a business's behalf. These third parties are bound by strict contractual terms to process data only according to instructions and to implement appropriate security measures. They are prohibited from using personal data for their own purposes.

Specifically, the following categories of service providers are used to support business operations:

- Cloud/CRM Service Providers: For the secure storage and management of client records (e.g., Podio.com, or similar cloud-based systems).
- Email Communication Providers: For sending business-related and transactional emails.
- IT and System Administration Providers: For maintaining IT infrastructure and systems.

Legal Basis for Sharing: The processing of data by these service providers is necessary for the performance of the contract between parties and to pursue legitimate interests (namely, to operate the business efficiently and provide services).

E. Data collection & process

Third parties are **required** to use the personal information transferred to them only for the purpose for which it was transferred and not to retain it for longer than is required for fulfilling the said purpose.

F. Retention Of Your Information:

Personal information **will be retained** for 90 days to 2 years after users terminate their accounts or for as long as needed to fulfil the purposes for which it was collected as detailed in this Privacy Policy. Certain information may need to be retained for longer periods such as record-keeping / reporting in accordance with applicable law or for other legitimate reasons like enforcement of legal rights, fraud prevention, etc. Residual anonymous information and aggregate information, neither of which identifies the user (directly or indirectly), may be stored indefinitely.

G. Your Rights:

Depending on the law that applies, you may have a right to access and rectify or erase your personal data or receive a copy of your personal data, restrict or object to the active processing of your data, ask us to share (port) your personal information to another entity, withdraw any consent you provided to us to process your data, a right to lodge a complaint with a statutory authority and such other rights as may be relevant under applicable laws.
